In addition to his commissioner duties, Rick served Former President of the North & East County Judges and Commissioners Association then moved on to become the State President of the County Judges & Commissioners Association of Texas in 2022. Rick also served as the Legislative Chair for the County Judges and Commissioners Association.

He currently serves as the Secretary on the Regional Transportation Council at the Council of Governments, and is a member of the Unified Scoring Committee. Rick is also a graduate of A&M V.G. Young Institute Leadership Academy. Rick has served in many different capacities for several State, regional, and local boards, as well as some

committees in the community over his 16 years of being County Commissioner for Precinct 1. Whether managing road issues or participating in Commissioners Court, Rick strives to address the concerns of the public he serves



Judge Boedeker and his wife, Andrea, are life-long residents of Johnson County. They reside in Cleburne, where they are raising their children. Before taking the bench, Judge Boedeker served as a prosecutor in Johnson County for 8 years and served on Cleburne's City Council. The County Judge serves as the presiding officer for the Commissioners Court. In Johnson County, the County Judge serves as the budget officer and chief executive for the County, overseeing many of the County's day-to-day operations. Other responsibilities include emergency management, public policy, presiding over the Elections Commission, serving on various boards, and appointing members to several boards. The County Judge

also has limited judicial responsibilities, presiding over some administrative hearings.

He is an advocate for civic involvement and was a long-time business owner in his community. He formerly served as a member on the Joshua YMCA Board of Directors. He is a founding member and past board member of the Chisholm Trail 100 Club, as well as a former member of the Joshua High

School Advisory Council. He and Tana are long-time members of Open Door Church and continue to serve on numerous boards and committees.

He is a 2014 graduate of the VG Youth Leadership Academy, 2014 recipient of the Commissioner's Court Advanced Curriculum Certification and has served as president of the Government Officials Council of Johnson County (GOCJC).

Commissioner Howell was initially appointed to the Johnson County Commissioner's Court in July of 2011. He served two years of a vacated 4-year term, and then was elected as the commissioner in 2014. Commissioner Howell is now serving his third term as Commissioner for Johnson County Precinct 2 Roads and Bridge.
