A graduate of Texas State University, he serves on several major boards, including the McLennan County Water Resource Group and the Waco-McLennan County Economic Development Corporation. Throughout his career, he has held leadership roles in organizations such as Texas Workforce Solutions and the Heart of Texas Council of Governments. His service has been recognized with numerous honors, including the 2025 Man of the Year in Texas Agriculture and the 2024 Thomas G. Salome, Jr. Legacy Award.

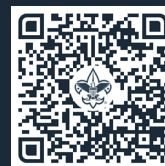
